7/16/19 - MIRU all safety equipment and POOH with production equipment. Set a 7" CIBP at 7670'.  
 7/17/19 - Tagged CIBP. Loaded and circulated with 300 bbls plugging mud to surface. Pressure tested to 500 psi for 10 min, test held. Pumped a 35 sx Class "H" cement plug plug from 7670'-7497' calc. WOC 4 hrs and tag. Tagged TOC at 7482'. Pumped a 40 sx Class "C" cement plug from 5650'-5404' calc.  
 7/19/19 - Tagged TOC at 5347'. Pumped a 25 sx Class "C" cement plug from 3500'-3346'. Pumped a 25 sx Class "C" cement plug from 2250'-2096'. Perforated at 1120'. Attempted injection rate into perfs to 500 psi, no rate. Pumped a 30 sx Class "C" cement plug from 1170'-986' calc.  
 7/22/19 - Tagged TOC at 975'. Perforated at 650'. Attempted injection rate into perfs to 500 psi, no rate. Pumped a 30 sx Class "C" cement plug from 700'-516'. WOC to tag. Tagged TOC at 530'. Perforated at 150'. Established injection rate to 500 psi. Full returns up 9-5/8" casing to surface. Pumped a 45 sx Class "C" cement plug from 150' up to surface down 7" casing and up 9-5/8" casing. Surface plug set.  
 8/29/19 - Cut off wellhead and installed dry hole marker. Cut off anchors and cleaned location as per regulated. **WELL IS PLUGGED AND ABANDONED.**
