7/23/19 – MIRU all safety equipment and POOH with production equipment.
 7/24/19 – Set a 7" CIBP at 7680'. Tagged CIBP. Loaded and circulated with 300 bbls plugging mud from 7680' up to surface. Pressure tested to 500 psi for 10 min, test held. Pumped a 35 sx Class "H" cement plug from 7680'-7507' calc. WOC to tag.
 7/25/19 – Tagged TOC at 7490'. Pumped a 30 sx Class "C" cement plug from 5520'-5336' calc. WOC to tag. Tagged TOC at 5328'. Pumped a 25 sx Class "C" cement plug from 3550'-3397' calc. WOC to tag. Tagged TOC at 3388'. Pumped a 25 sx Class "C" cement plug from 2220'-2067'. Perforated at 1120'. Attempted injection rate to 500 psi, no rate. Pumped a 30 sx Class "C" cement plug from 1170'-986' calc.
 7/26/19 – Tagged TOC at 983'. Perforated at 650'. Attempted injection rate to 500 psi, no rate. Pumped a 30 sx Class "C" cement plug from 700'-516' calc. WOC to tag. Tagged TOC at 498'. Perforated at 150'. Attempted injection rate to 500 psi, no rate. Pumped a 35 sx Class "C" cement plug from 220' to surface. Topped off casing with cement. Surface plug set.
 8/29/19 – Cut off wellhead and installed dry hole marker. Cut off anchors and cleaned location as per regulated. **WELL IS PLUGGED AND ABANDONED.**
