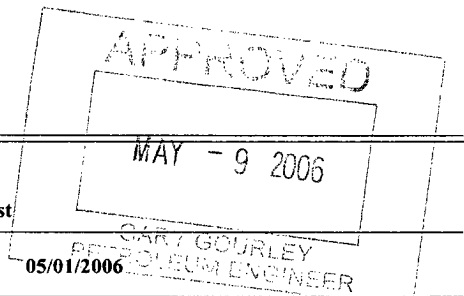

4/26/06 - Tagged plug @ 563'. Perf 5 1/2" csg @ 60'. Circ 30 sx cmt down 5 1/2" csg & up 9 5/8" csg to surf. CWI w/ 1000#. WOC. Rls press. Cmt @ surf. Dug out cellar. Cut off wellhead. Install dry hole marker. RD.
