 9-4-19 - Load and Circ. 7" CSG from 5450' to surface with 200 bbls plugging mud. Pressure tested to 500 psi for 10 minutes and held. Set EOT @ 5450' pumped 25 sx Class "C" Cement to Calc. 5296'. Tagged TOC @ 5283'. Set EOT @ 4250' pumped 25 sx Class "C" Cement to Calc. 4096'. Set EOT @ 2050' pumped 25 sx Class "C" Cement to Calc. 1896'. Perforated 7" CSG @ 1265' attempted injection rate up to 500 psi and no rate. Set EOT @ 1315' pumped 30 sx Class "C" Cement to Calc. 1131'.  
 9-5-19 - Tagged TOC @ 1146'. Set EOT @ 550' pumped 25 sx Class "C" Cement to Calc. 396'. Perforate 7" CSG @ 150'. Attempt injection rate into 7" CSG 500 psi. No rate. Set EOT @ 150' pumped 25 sx Class "C" Cement circulated to surface.  
 9-10-19 - Cut off wellhead and installed dry hole marker. Cut off anchors and cleaned location. **WELL IS PLUGGED AND ABANDONED.**
