COG Operating, LLC. respectfully requests authorization to construct, operate, maintain, and reclaim an overhead powerline for the Quien Sabe Federal Com 601H, 602H, 701H, 703H, 800H, 801H, and the Quien Sabe Federal Com Central Tank Battery (CTB). The overhead powerline will be a three phase 7.2/12.47 kv powerline on 14-40 ft. and 45 ft. poles with span lengths of approximately 300 ft. and 350 ft., respectively. The overhead will begin in the NE1/4NE1/4 of section 24, T. 24S., R. 27E. at the take off point. The powerline will travel west and drop south to the CTB and last location to the west. The overhead powerline on federal lands will be 3,480.0 ft. (0.65 mile) in length, 30 ft. in width for a surface disturbance of 2.37 acres. The overhead powerline on federal lands will be in section 24, T. 24S., R. 27E.

A PBPA contribution for archaeology will be made to the BLM.


