Circ 212 sks of cmt to the pit. Test BOPE to 5000# & Annular to 3500#. At 6:15 A.M. 11/26/19, tested csg to 1500# for 30 mins, held OK. FIT to 10.5 PPG EMW. Drilled out with 12 1/4" bit.




