Production casing test per 19.15.16.10 (I) was conducted to 6100 psi for 5 minutes, successfully demonstrated integrity. Test did not meet requirements of 10(i) in that test did not extend for 30 minutes. Discussed issue with Ray Podany, he suggested C-103 for exception to requirement for this well.

We have put procedures in place to make sure that the production casing is tested for 30 minutes as per rule for all future wells.
