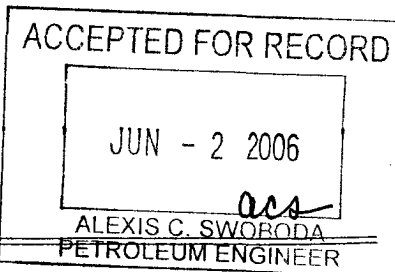

NU BOP's. Test BOP & csg to 2000# for 30 mins ok.
