Tag cmt. plug @ 1636', pull up to 350', shoot squeeze holes. Pump 96 sks cmt down csg and circulate to surface. ND BOP, dig up cellar, cut off wellhead, set dry hole marker. Note: All cmt. pumped was P+ (Class C).
