07-07-06: Drill out float collar and hard cement to 467' (7' below shoe). Tested Liner and shoe to 1000 psig for 30 minutes, OK.
Drilled out CIBP at 1095' K.B.
Reamed and washed down to 5970', pipe stuck, pulled free. Cleaned out and drilled down 5575', pipe stuck. Ran chemical cutter and cut off and pulled 2-7/8" tubing at 5356'; left 10' piece of 2 7/8" tubing, (4) 4-3/4" DC, (2) 6" DC and 6-1/4" bit from 5356' to 5552' K.B. Received verbal P&A instructions from Van Barton with the NMOCD
