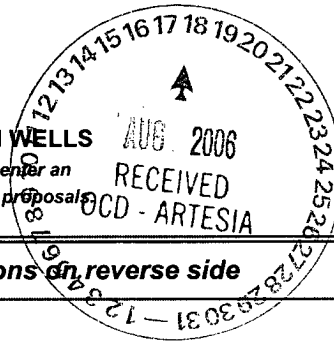

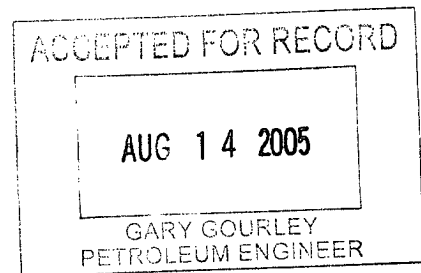

7/1/2006 Frac'd with 9,680#, 18/40 Versaprop with 34,000 gals slick water. Flowing well.
