7/24-25/06 Unable to run logs. Run total 99 jts (4192') 7" 23# K55 New R3 LT&C csg(79 JTS W/Ryt-Wrap CTG), 9 jts of 4 1/2" 10.50 casing @ 290'. 24-6 1/2" x 31' drill collars. Halliburton cemented w/ 1200' sks of HLP+ & 500 sks of 50/50 Poz, did not circulate Cement down 3:00 a.m. 7/25/06. Notified BLM's Paul Swartz of cement time. BLM was a no show. Release rig @ 10:00 AM 7/25/06 & move off location.
