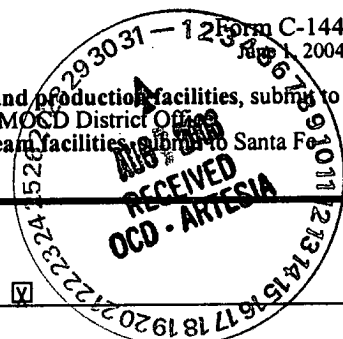

Additional Comments: All contents will be mixed to stiffen, encapsulation trench will be dug and lined with 12-mil liner; drilling mud will be placed in lined trench; a 20-mil synthetic liner will be placed over the pit contents with a 3' to 4' overlap. The encapsulation trench will then be backfilled to graded with a minimum of 3' of clean soil and like material.
