Threshold Development Company respectfully requests permission to lay a temporary 3" poly (fas-line) water line along the existing two track road and seismic route across the east half of Section 28-T25S-R18E, to provide the drilling rig with fresh water. This line being laid will substantially reduce the truck traffic, dust and road wear.

Everything will be on lease. A cultural report was done on the seismic route in 1999.

A copy of the fresh water test will be provided under separate cover.
