07/28/06 Ran 13-3/8" 48# H-40 STC casing to 510'. Cemented with 51 bbls RFC - Class A + 10% gyp + 2% CaCl + 5 pps Gil. + 0.125pps Celloflake. Then added lead of 105 bbls 35/65 poz + 6% bentonite + 3% CaCl + 5 pps Gil + 0.125 pps Celloflake and tail of 48 bbls Class C + 2% CaCl + 0.125 pps Celloflake. Circulated 39 bbls cement to pit. Pressure tested casing to 1000 psi. WOC total of 22.5 hours.

08/03/06 Ran 9-5/8" 40# J-55 LTC casing to 3123'. Cemented with lead of 775 sx 50/50 poz (yld 2.47, wt. 11.9) and tail of 200 sx class c + 2% SOO1 (yld 1.34, wt 14.8). Circulated 172 sx to surface. Pressure tested casing to 1000 psi for 30 minutes. WOC total of 37 hrs.
