This well was originally operated by Pan America Petroleum Corp. and plugged on 03/22/1960.

Re-enter to re-plug as per NMOCD Order No. R-12658. Re-enter the well and drill out any plugs down through the permitted injection interval, run a bond log to determine cement top behind the existing production casing. We cannot, at this point, correctly determine how we are going to plug until we re-enter the well, clean out, and run the bond log. Once we determine our downhole situation we will submit (while we are on the well) another Form C-103 with the proper plugging procedure.
