10/19/06 - Tag @ 727'. Shoot 4 sqz holes @ 510'. Pump 40 sx cmt plug. Tag @ 385'. Shoot 4 sqz holes @ 100'. Pump 40 sx cmt.

10/20/06 - Pump 40 sx cmt. Tag @ 75'. Top out w/ 15 sx cmt. Cut off wellhead & install dry hole marker.
