10/17/06 - Tag @ 395'. Shoot 4 sqz holes @ 375'. Kent w/ BLM OK'd perfin. Gene w/ BLM OK'd spotting cmt. Spot 20 sx cmt @ 361'. WOC. Tag @ 152'. Shoot 4 sqz holes @ 60'. Kent w/ BLM OK'd plug. Pump 20 sx cmt. Circ to surface. Cut off wellhead. Install dry hole marker.
