12/29/06 - Acidize Morrow 11,194'-11,204' with 500g 7-1/2% Morrow acid. Acidize Morrow 11,136'-11,146' with 500g 7-1/2% Morrow acid.

1/3/07 - Set a CIBP at 11,100' with 35' cement on top. Perforate Atoka 10,844'-10,850' and 10,916'-10,922' for a total of 72 holes. Set packer with 2.25" on/off tool at 10,756'. Acidize with 1500g 7-1/2% IC acid with 1000 SCF/bbl N2.
