A successful Mechanical Integrity Test was performed on the referenced well on 12/21/06 and the original chart was retained by the NM OCD, District II. A CIBP was set at 1613' and the hole was circulated.

This well is in our waterflood area. The well therefore has utility should additional intervals in the San Andres be perforated and flooded. As the ASAU is expected to produce for quite some time, the potential usefulness of this well will also be ongoing. As this situation is not expected to change, we are requesting a longer term temporary abandonment status.
