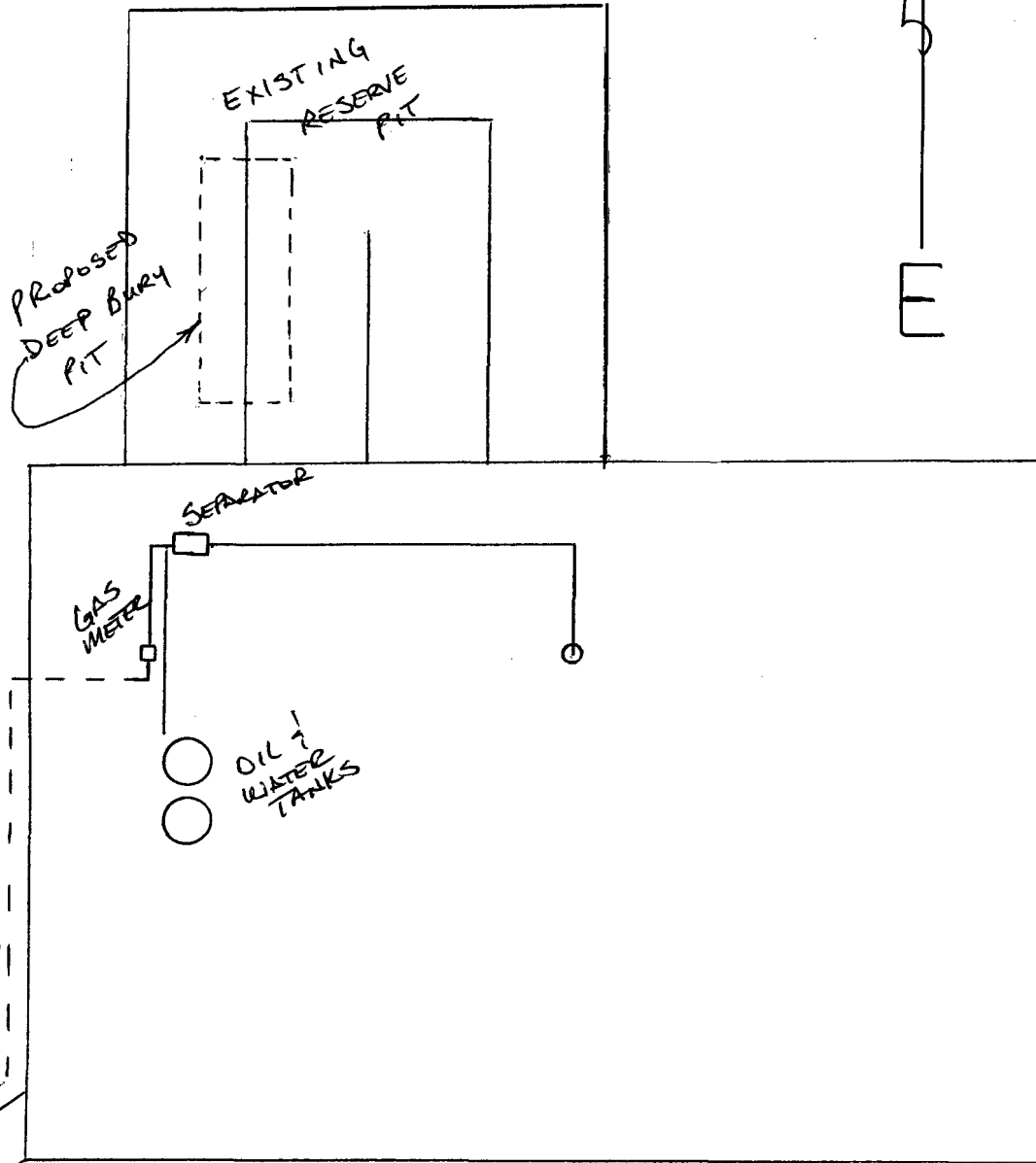

Both pits will be closed during the operation. We will start the "clean up" as soon as the equipment is available following NMOCD approval. As a condition of approval, if during pit construction water is encountered or if water seeps in pits after construction the OCD MUST BE CONTACTED IMMEDIATELY!
