Tail with 350 sks Class H with additives. Mixed @ 15.1 #/g w/ 1.28 yd. Circ 120 sks to pit. Lift pressure at 1950# at 2.5 BPM. At 5:00 pm 02/07/07, tested 4 1/2" casing to 2300# for 30 mins, held OK. Set 85k on slips.

02/09/07...Released rig at 5:00 am 02/08/07.

02/13/07...Ran CBL and found TOC at surface.


