Devon Energy Production Company, LP is applying with the NM OCD for approval to downhole commingle the Red Lake Queen-Grayburg-San Andres (51300) and the Northeast Red Lake Glorieta Yeso (96836) pursuant to 19.15.5.303 (C) 3 (b) Exceptions for wells located in pre-approved pools or areas. This pool was pre-approved by NM OCD Division order PC-1108.

The San Andres is perforated at 2244-2824' and the Yeso is perforated from 3103-3357'. Average production from the SA is 11 oil and 14 gas. Average production from the Yeso is 11 oil and 28 gas.

The allocation method is by ratio of stabilized production. For the Yeso, oil is 50.0% and gas is 66.7%. For the San Andres formation, oil is 50.0% and gas is 33.3%.

Commingling these two pools will not reduce the value of the total remaining production and the ownership between the two pools is identical.


