Will convert oil well to water injector as part of 8 well waterflood (described in 3 ring binder application received by BLM 2-20-07).

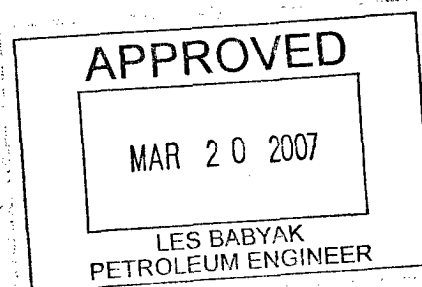
Will set Model R injection packer or its equivalent approximately 100' above highest Paddock perforation.
