Will run 6.5# internally plastic coated tubing string.

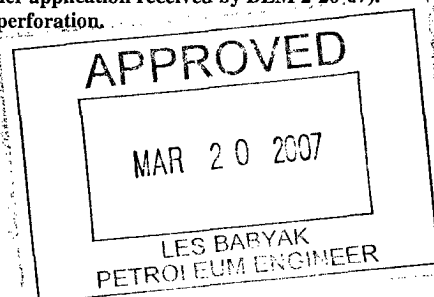
Stimulate with approximately 5,000 gallons 15% NEFE HCl to clean out scale or fill.
