

Will notify OCD and run MIT for TA'd well status. Ran good MIT. Pressured csg to 580# and charted 30 min. Test witnessed by Richard Inge w/OCD and Cheryl de Montigny w/BLM. Original chart was retained by NM OCD. Copy of chart is attached.

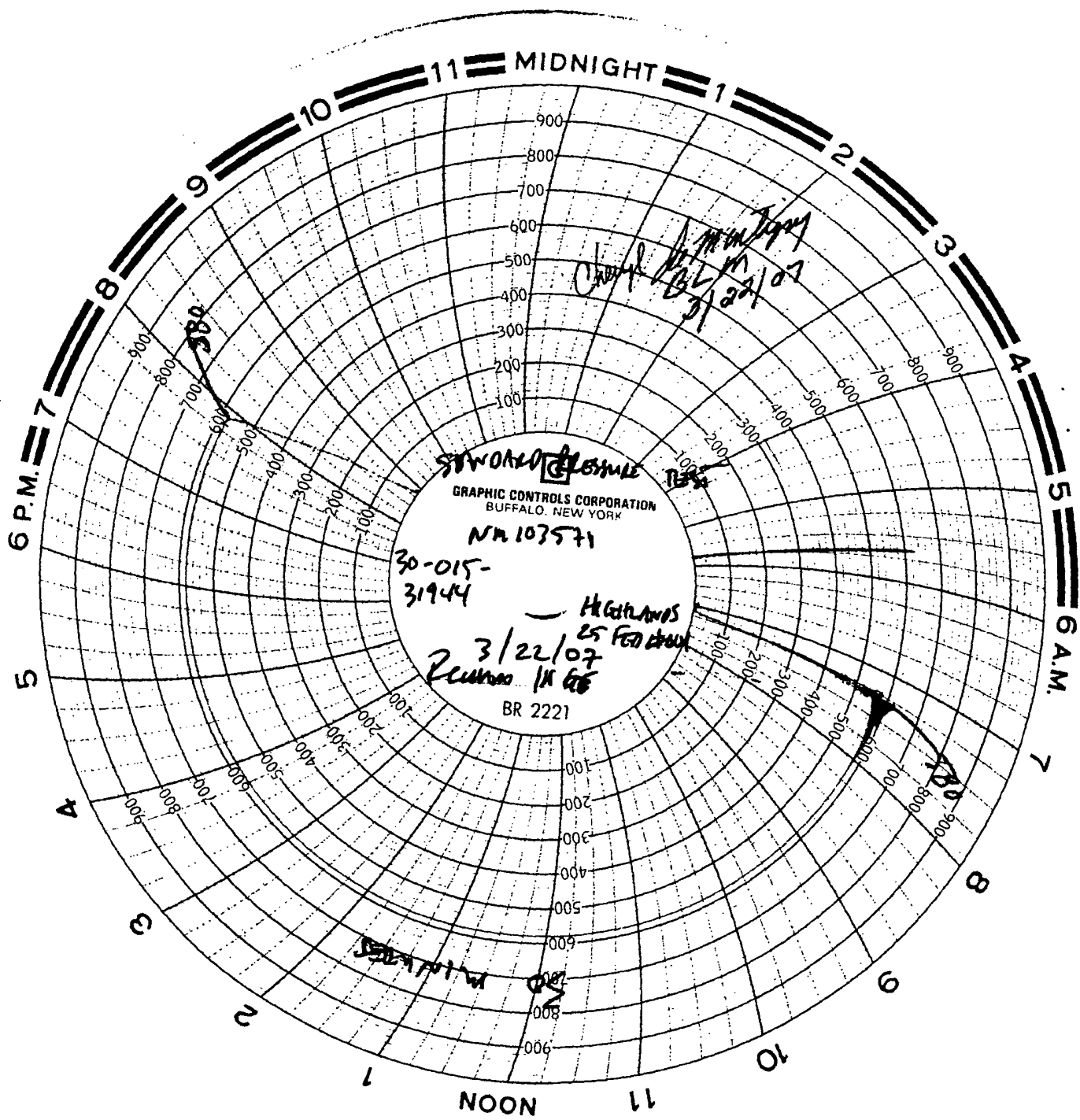
