1. NOTIFY NMOCD AT LEAST 24 HOURS BEFORE STARTING PLUGGING WORK. Call office for new directions if any abnormalities are noticed during plugging operations for the well. MIRU WSU & all safety equipment as needed. Load tubing & casing w/ 2% KCL water, ND wellhead, and NU BOP; POH w/ tubing.

2. RU wireline & RIH w/ 4-1/2" gauge ring to 3700' to make sure casing is clear; RIH w/ 4-1/2" CIBP & set plug @ 3700'. RIH w/ tubing to top of CIBP & circ hole w/ 10.0 ppg mud w/ 25# bbl gel in mud, then spot 25 sx cement on top of CIBP - POH w/ tubing.

3. RU wireline & RIH w/ perforating gun & shoot 4 holes @ 1850', then RIH w/ a packer on the tubing to 1800' & squeeze 50 sx cement behind casing to cover base of 8-5/8" casing; POH w/ tubing & packer. RIH w/ perf gun & shoot 4 holes @ 100', screw in a casing swedge & squeeze 50 sx cement behind casing to surface. Spot 5 sx cement @ surface to fill casing if necessary.

4. ND BOP & remove wellhead; install regulation dry hole marker & clean location.

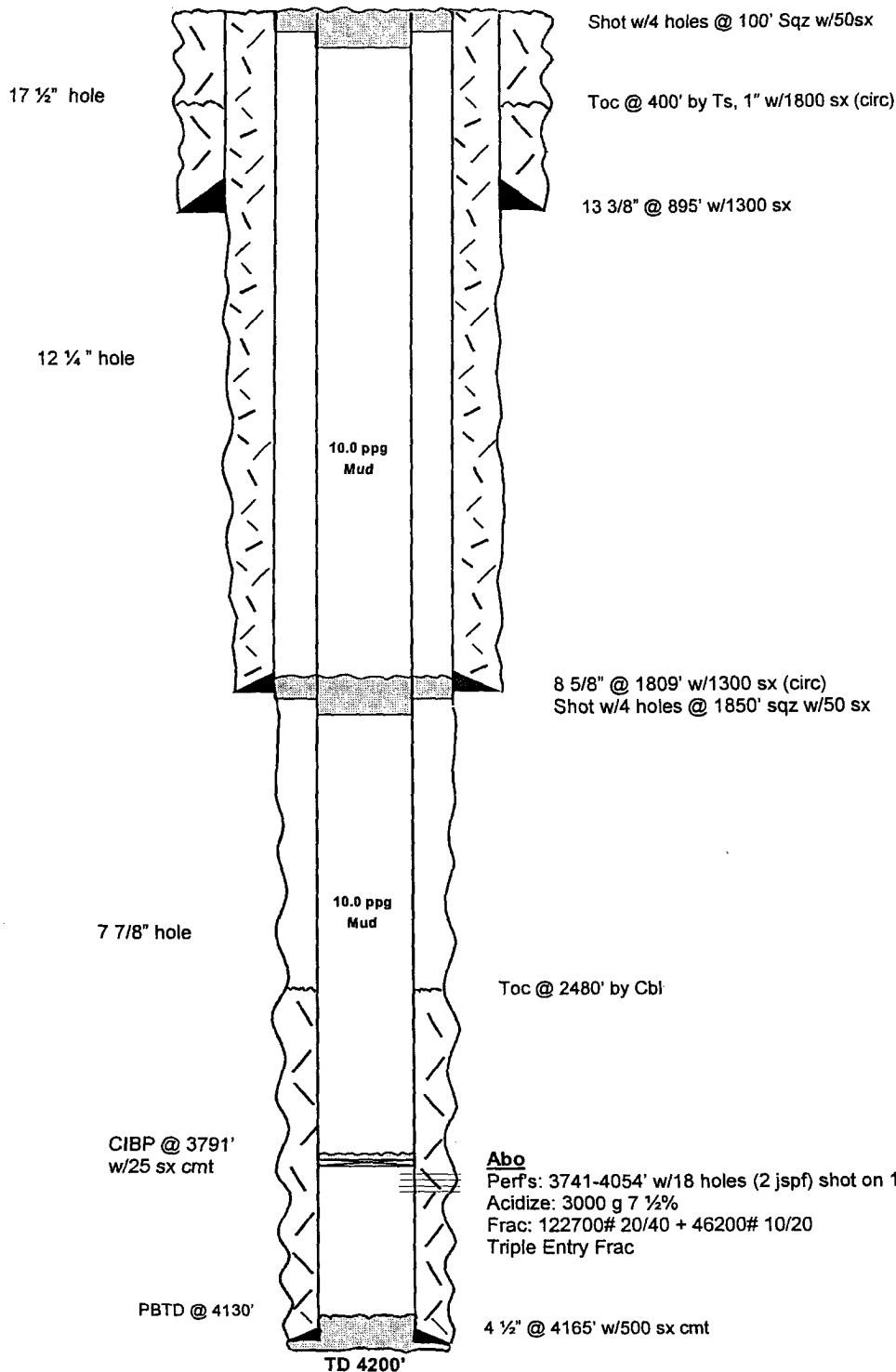
