- 3/9/07 Jay onto RBP at 7638'. Bottom part of jay slot corroded away. Two steel pieces of metal on top of RBP.
3/10/07 Released RBP at 7638'. Unable to pull RBP. Worked down 20'. Pulled 2-7/8" tubing and RBP very slowly out of hole. Removed 1 piece of steel off RBP. Possibly 1 piece steel in hole.
3/12/07 TIH to 7900'. Perforations were clean.
3/13/07 Set a cement retainer at 7652'. Tested retainer, OK. Squeeze Canyon perforations with 650 sx Class "H" cement N2 foam. Re-squeeze with 450 sx Class "H" cement and 2000g flocheck.
3/14/07 Squeezed Canyon perms with 1500g Flocheck, 150 sx Thixotropic Class "H" cement and 100 sx Class "H" Neat. Squeezed off to 3000 psi. Held pressure.
3/15/07 Tagged retainer at 7652'. Drilled out retainer and cleaned cement down to 7688'. Circulate hole clean.
3/16/07 Tagged up on cement at 7688'. Cleaned out to 7760' and fell out of cement. Squeeze to 1000 psi for 20 min, held good.
