Cimarex Energy Co. of Colorado requests to bury the drill cuttings from our Grynborg 11 Fed Com No. 3 well located in L-11-25S-26E on lease and on the well pad of our Grynborg 11 Fed Com No. 4 well located in D-11-25S-26E.

The sub surface of the No. 3 well pad is too hard to trench and bury the drill cuttings while the No. 4 well pad has sufficient room and an adequate sub surface to trench and bury the cuttings from both wells. The No. 3 cuttings will be picked up and hauled by truck approxiamtely 2500' on existing lease roads and trenced and encapsulated in a 20 mil liner with 3' of top soil on top. Both pit areas will be contoured and remediated according to BLM standards.
