We propose to temporary abandon this well to give us time to determine the down hole problem and repair to return to production or to secure an approved P&A plan . We will immediately clean up any spill and secure the well.

This well bore was drilled in 10/1939 as an oil well. It was converted to a Grayburg Jackson SAU oil producer in 1/1966. GJSAU zone was P&A in 2/1997. Ran 77 jts 3402' new 4-1/2" casing with total of 320 sks cement. Perforated casing from 2863' to 3026' as non- unit Grayburg. Well was producing in the 3 BOPD range when it went down.
