RU 6/28/07. Pressure test 7" and 9-5/8" annulus to 550# for 30 minutes. Test witnessed and approved by BLM, chart attached.

Pressure test the annulus between the 7" and 9-5/8" casing stings. The pressure test will be 500 psig, held for 30 minutes and recorded on a chart. BLM will witness the test. A successful test will fulfill the requirements under the incident of non-compliance and no perforation and circulation of cement at +/- 2400' will be required as agreed to today by OXY and the Carlsbad, NM-BLM. The casing and cementing history will be reviewed upon final abandonment of the well.
