6/13/07 Tag cement @ 855' & drill to 950'. Tag CIBP, test to 500 PSI- no leak off. Drill out CIBP- well on vacuum, tag bottom. LD bit & DC'S. 6/14/2007 Run 155 jts(4990') 2-7/8" 6.50# J55 tbg, TAC @ 4637'. Run pump and rods and return well to pumping to Jackson A Lease tank battery @ 1:00 PM 6/14/2007.
6/8-13/2007 effort to bring 7" cement to surface using BLM plan and ours unsuccessful. (There is a washout from approx. 340' to 750'.)
