• Opened well, no pressure

• Pulled swab, 250 feet of fluid fill over nite with live oil to pit. Water looked like drilling fluid.

• Pick up and set packer. Attempt to acidize down annulus - top perfs at 847 - 857

• Acidize lower perforations with 400 gallons 7 1/2% - breakdown at 1250 psig.

• Pull packer and tubing

• Run retrievable plug & set at 864. Pull packer to 808 & set

• Acidize upper perforations with 400 gallons 7 1/2% - high pressure, never got good break, pumping at 1900 psig

• Swab well, recovering acid water

Will shut in well overnight for buildup and swab in morning on upper perforations. Then pull the bridge plug and swab on the lower perforations. Plan to pull tubing after swabbing, probably Thursday and leave open in anticipation of frac job.
