Yates Petroleum Corporation plans to plugback and recomplete this well as follows: Release packer and RBP. Set a CIBP at 11,650' with 35' cement on top. Perforate Bone Spring 9636'-9646' (21), 9664'-9678' (29), 9756'-9762' (13), 9786'-9796' (21) and 9840'-9850' (21). Stimulate as needed. If the well is still non-commercial, perforate additional Bone Spring 9040'-9050' (21), 9066'-9070' (9), 9088'-9096' (17) and 9114'-9116' (5). Stimulate as needed.
