

TD & Production Csg - Drld 7-7/8" hole to 8100'. TD reached @ 21:00 hrs 08/03/07. Logged well w/ Halliburton. Ran 193 jts 5-1/2" 15.5# & 17# J-55 LT&C csg. Cmt'd 1st stage w/ 500 sks CI C + add. Circ 119 sks to surface. Cmt'd 2nd stage w/ 800 sks CI C + add. Circ 175 sks to surface. Cmt'd 3rd stage w/ 250 sks 65:35 POZ C followed by 200 CI C + 2% CaCl2. Circ 26 sks to surface. Test csg to 2500# ok. Ran CBL 08/11/07.
