Marathon Oil Company has completed operations to run a one month test for economic viability and test of production liner on the MOC Federal No 8. The one month test ended 10/23/2007. Marathon is currently producing gas off this well to the MOC Federal Central Facility. Gas is being sold into the loop line after being metered through the MOC 'East Test Separator'. This set up for separation and sales is a temporary arrangement until Marathon can set a permanent separator for the MOC Federal No 8 well. Please see attached copy of current battery diagram.
