ConocoPhillips, as operator of the Grayburg Deep Unit No. 14 well, hereby requests approval from the New Mexico Oil & Gas Conservation Division ("NMOCD") to temporarily abandon the existing Morrow formation completion in Well No. 14, and to permit the recompletion of the well as an oil and gas producer in the Wolfcamp formation. This action has been requested in order to protect the correlative rights of the interest owners in the well from drainage from a recently completed Wolfcamp formation producer in the adjacent spacing unit. Further discussion of this issue is provided below.

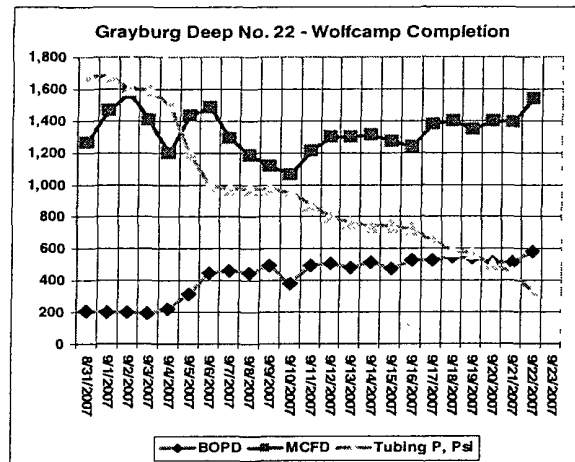
I. BACKGROUND

The Grayburg Deep Unit Well No. 14 is located 868' FNL, 1,062' FWL of Section 25, T17S, R29E, Eddy County, New Mexico. The well was drilled and completed as a Morrow formation producer in the fall of 1997. First production was reported in December, 1997. As of July 2007, the well has recovered 1,296,223 MCF of gas and 17,962 bbls of oil, with the well still producing at a rate of 201 MCFD / 1 BOPD.

An offsetting Morrow formation producer was drilled in the fall of 2006. The Keely 26 Fed No. 1, has a surface location of 1,800' FNL, 990' FEL of Section 26, T17S, R29E. The Morrow formation in the Fed No. 1 well was completed and tested in the Morrow during October – December 2006. During the test period, the Morrow interval was produced at rates from 300 – 400 MCFD at 50 – 70 psi. In December 2006, the Morrow completion was isolated with a retrievable bridge plug. Following this, the Wolfcamp formation was completed in the well in the interval from 9,078' – 9,188'. Following stimulation, the well was placed on production. As of July 2007, cumulative production from the Wolfcamp has been 18,627 bbls of oil and 245,214 MCF. The July 2007 production rate was 24 BOPD / 644 MCFD.

A second offsetting Wolfcamp producer was drilled in the summer of 2007. This well, the Grayburg Deep Unit No. 22, is located 1,940' FNL, 330' FWL of Section 25, T17S, R29E. The well was completed in the Wolfcamp formation interval from 9,088' – 9,158'. As the well has only been on production since August 31, 2007, only a limited amount of production data is available. Initial production rates have

been high, but the well is experiencing a steep decline in producing pressure as is indicated in the plot below:



Morrow formation well spacing was fixed at 160 acres. Both the Keely 26 Fed No. 1 and Grayburg Deep Unit No. 14 were situated in locations that met the requirements for 160 acre spacing units. The Grayburg Deep Unit No. 22 well targeted the Wolfcamp and was permitted under the restrictions of a 40 acre spacing unit,

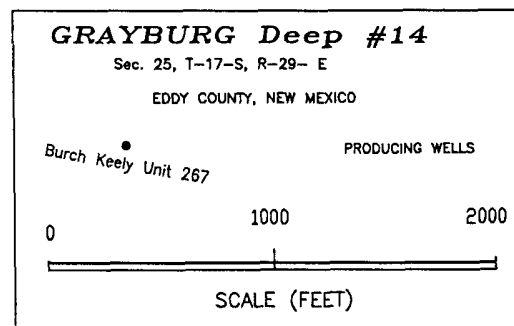
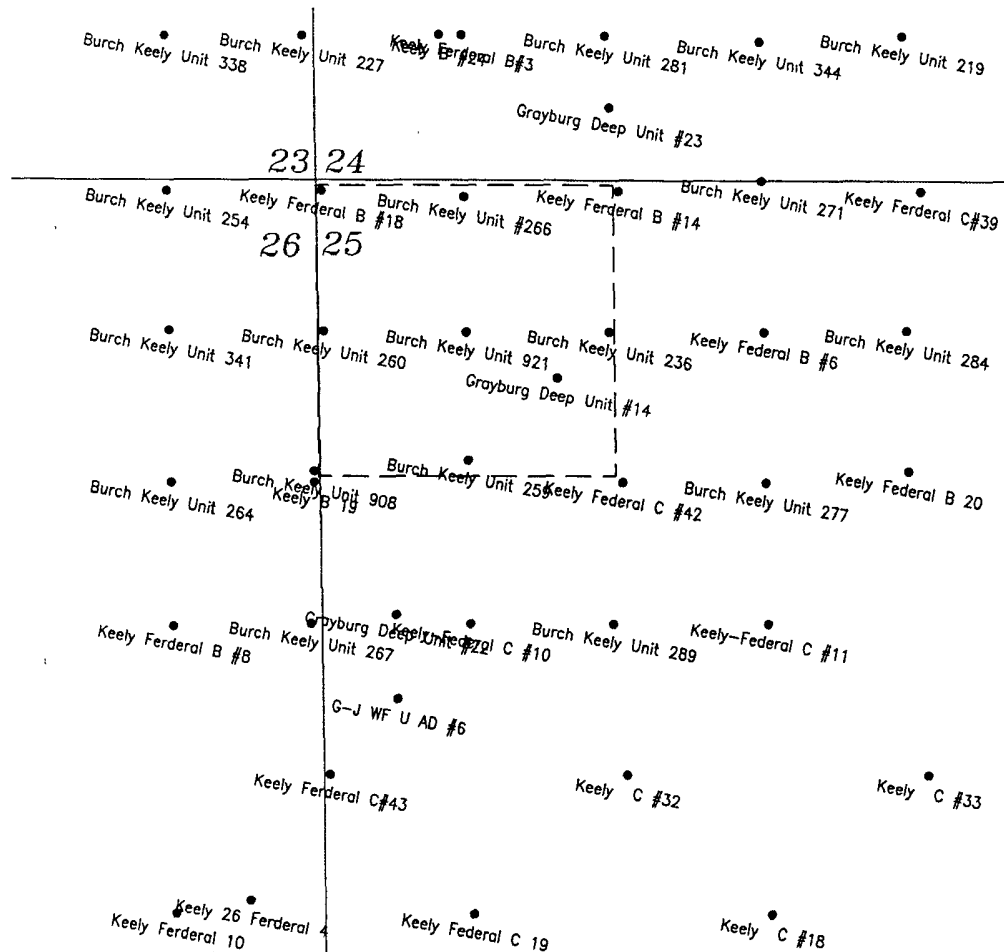
II. PROPOSED WOLFCAMP RECOMPLETION

Current ConocoPhillips mapping of the Wolfcamp formation indicates that there is a limited amount of reservoir present in the west half of Section 25. While the Keely 26 Fed No. 1 well encountered 110 gross feet of productive Wolfcamp interval, only 70 gross feet appears in the Grayburg Deep Unit No. 22 well. Reservoir quality does deteriorate further to the north, so that only 46 gross feet of pay are observed on the log from the Grayburg Deep Unit No. 14 well.

The 40 acre Wolfcamp spacing unit for the Grayburg Deep Unit No. 22 well is located in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 25. Simple volumetric reserve calculation indicates that at best there may be approximately 60,000 bbls of recoverable oil contained in that spacing unit. The cost of drilling and completing the Grayburg Deep Unit No. 22 well was estimated at approximately \$2.5MM. Preliminary ConocoPhillips economic evaluation indicates that the Wolfcamp reserve base in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ Section 25 is insufficient to support a comparable grass-roots Wolfcamp well.

The cost of recompleting the existing Grayburg Deep Unit No. 14 well as a Wolfcamp producer has been estimated at approximately \$0.37MM. The reserve base in the NW ¼ NW ¼ is sufficient to pay out the cost of this work. Accordingly, authorizing the recompletion of Well No. 14 will allow ConocoPhillips to produce the Wolfcamp reservoir and protect the correlative rights of the working and mineral interest owners.

As was mentioned above, the Grayburg Deep Unit Well No. 14 is currently producing from the Morrow at a rate of 201 MCFD / 1 BOPD. In order to produce the Wolfcamp interval, the Morrow formation completion will be isolated by means of a retrievable bridge plug. Once Wolfcamp reserves have been produced, the Wolfcamp perforations will be cemented off, the bridge plug retrieved and the Morrow formation completion will be reactivated.
