12/26/07 Resumed drilling at 7:30 AM.

12/27/07 Set 13-3/8" 48# H-40 casing at 425'. Cemented with 165 sx Halliburton Premium Plus SBM + 3# Phenoseal + 0.125#/bbl Poly-E-Flake + 1% CaCl (yld 2, wt 12.5). Tailed in with 200 sx Premium Plus "C" + 2% CaCl (yld 1.35, wt 14.8). Cement circulated to surface. Reduced hole to 12-1/4" and resumed drilling.
