2. ~~Set 52 sks Cement~~ Cement Plug 2380' - 2345' (30+Feet). WOC. Top of Cement - 2070' Shoe plug @ 852' & tag; Shoe plug @ 95' & tag. Surface plug set @ 50'. Displace Casing with Mud or Brine Gel between Cement Plugs

PERF @ 145' AND SQUEEZE CMT. PLUG. COMBINE SHOE PLUG & SURFACE PLUG

3. Install Dry Hole Marker, Clean Location, Level Pits, Rat Hole and Cellar. Set 4" Steel Marker, Clear Location cleared of all Debris and Equipment.

4. Notify BLM and NMOCD of Plugging Operations.
