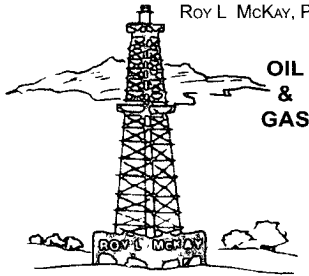

Carol has been working diligently on non-compliance wells. This particular well which is the South Four Mile Draw B Federal 8 was a well that we started drilling and had to abandon and move over and redrill which was then named the South Four Mile Draw B Federal 8y API # 3000563639. Evidently our office reported production under the incorrect API#, and this is where the problem lies. November 2003 production reported under incorrect API with production reported of 2955mcf, Dec 2003 2472 mcf, Jan 2004 1504 mcf, Feb 2004, 340 mcf and then in May 2004, 2024 mcf. All of this was corrected in our system to reflect the correct API, however not in yours. Please advise on how we can correct this in your system and get off of the non-compliance list.
