Reserve Pit Closure

On 12/13/07, Shull Oilfield Service mobilized personnel and equipment to the location. In accordance with NMOCD instructions and guidelines, the 12 mil liner was folded over and a 20 mil cap was then placed on top. Three feet of backfill material from the stockpile was then placed over the 20 mil cap. Work was completed on 12/13/07. As per NMOCD instructions no soil samples were taken, due to the depth of ground water. Red capped posts were placed at each end of the former pit to mark its location.
