Cemented 2nd stage w/550 sks BJ Lite Class H (35:65:6) with additives. Mixed @ 12.5 /g w/1.95 yd. Tail with 200 sks Class H Neat. Mixed @ 15.6 /g w/1.18 yd. Slow rate lift pressure @ 1606# @ 3 BPM. Plug down at 11:00 am 01/23/08. At 11:00 am on 01/23/08, tested csg to 3050# for 30 mins. Set casing slips w/125k. Test tbg spool pack off to 2500#.
