13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. At the request of the BLM office in Carlsbad NM, this notice is for the reduction of the size of the drilling pad for the above mentioned well site. The location will be downsized to the dimensions shown on the attached drawing. Due to the fact that this is a deep, horizontal gas well and that the production equipment is located on the well site, the pad will be reduced as noted on the drawing. For safety concerns, the pad must be at a minimum the size noted on the drawing due to the location of the production facility and the potential for a large amount of equipment that will be required on the site if a workover or other stimulation work is to be performed. Additionally, there are cut and fill issues, if additional space is needed, the equipment could not be located off the pad as it could if the well were located in a flat area. Once the caliche is removed, the area will be recontoured and seeded to BLM specifications for this area.

Currently Parallel Petroleum Corp is conducting a large seismic program in this area. Upon completion and review of the data additional drilling is planned. It is therefore requested that the work to be performed be done in conjunction with the new drilling that is expected in the area. If this drilling program is not started before the second quarter of 2009, the pad work will be performed and the caliche stockpiled for use at a later date.

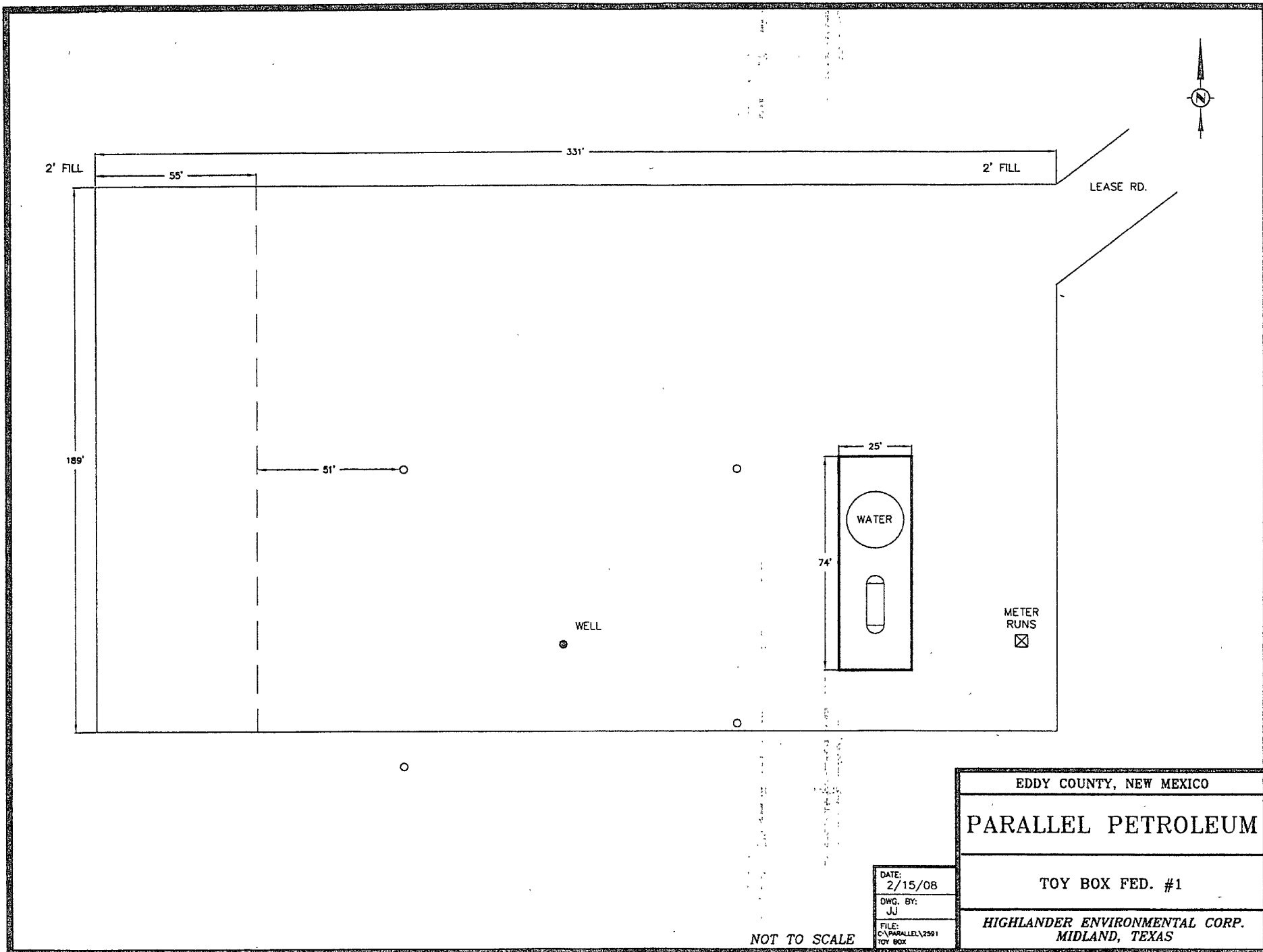
