BEPCO, L. P. respectfully requests permission to add Delaware perforations to the subject wellbore as follows:

RIH and set CIBP @ ~6350'. Perforate Delaware @ 6278'-6288' w/ 2 JSPF for a total of 20 holes. Spot 1000 gals 7.5% NEFE HCL across new perfs & fracture w/ 22477 gals BFRAC 3 & 61000 #'s 16/30 Ottawa Sand & 20000 #'s 16/30 Super LC Proppant.

RIH and set CIBP @ ~6100'. Perforate Delaware @ 6026'-6036' w/ 2 JSPF for a total of 20 holes. Fracture newest perfs w/ 22500 gals BFRAC 30 & 61000 #'s 16/30 Ottawa Sand and 20000 #'s 16/30 Super LC Proppant.

Drill out CIBP ~6100' and clean out to PBTD of ~6350'. RIH w/ 2-7/8" production string w/ SN @ ~5700" and TAC five joints above the top perf at 6026'. Return well to production from new perfs for approximately 3 months.

Drill out CIBP @ 6350' and produce all delaware perfs
