1. Re-check pump action to check for parted rod or hole in tubing
2. MIRU Service Rig and tie to permanent anchors
3. POOH with rods. If rods are parted pull with the tubing.
4. POOH with the tubing. If parted use overshot to fish
5. Tag well for PBTB
6. GIH with tubing, run insert pump on rods and space out
7. Put well on pumping and check for pump action.
8. Report on tubing and rods details
9. Rig down and move rig off location. Put well on production.
