1. Check for overhead power lines. Check wellhead pressure. RU DDP.
2. POOH with rod and pump.
3. POOH with tubing.
4. RIH with tubing and tag for fill. (PBTD at 8104)
5. RIH and set RBP at 7400' and cap with sand.
6. Perforate 7358-63' with ~12 total holes (2-jspf) using 4" OD ported gun with 120° phasing
7. RIH with packer set at 7200' and break perfs down with 1000 gal 7.5% HCl at 4 BPM.
8. Swab well and report findings to engineer.
9. If zone warrants fracture treatment, go to step 10, If does not warrant frac skip to step 11
10. Sand frac well per Halliburton's procedure. Shut well in for 24hrs to let resin set.
11. POOH with RBP
12. RIH with the pumping equipment.
13. PWOP
