5. Reset packer below new perfs and treat existing perfs 10,940' -50', 10,952' -58' and 10,960' - 66' with methonal. Swab test.
6. Raise packer above all perfs and acidize new and existing perfs w/3000 gals 7-1/2% HCL acid and ball sealers.
7. Test well and retun well to production.
