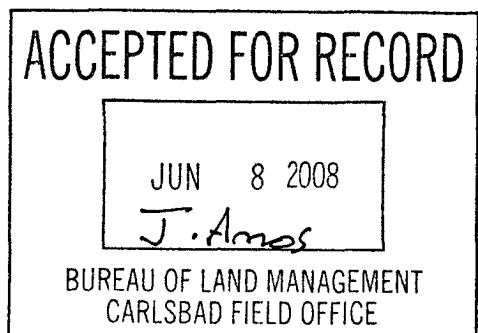

Pull rods and tubing
Set retrievable bridge plug @ 816'
Install packer @ 758' on 2 3/8" tubing
Perforate 790'-804'
Acidize with 1500 gal. of 7 1/2% NEFE and flush with 30 barrells of fresh water
Run rods and tubing and return to production.
