Moved in Permian Rig #1 Spudded well at 00:00 hrs. on 4-18-08.

Drilled 17-1/2" hole to 830'. Ran 13-3/8", 54.5#, J-55, ST&C casing. Landed casing with shoe @ 830', float collar @ 789'. Cemented surface casing with 432 sx. 35/65 Poz/C with additives (1.95 yield and 12.7 ppg) followed by 200 sx. Class C with additives (1.34 yield and 14.8 ppg). Displaced cement with 22 bbl fresh water and 100 bbl. of mud. Circulated 31 bbl. cement to surface. Float held. Shut-in well and waited on cement.

Welded on 13-5/8" casing head. Pressure tested to 500 psi. Installed and tested 13-5/8" BOP. Pressure tested BOP to 1,000 psi. Picked up drilling assembly. Drilled out surface casing shoe (25 hrs. since cement in place).
