Set isolation plug @ 11080' w/35' cmt. PBTD @ 11045'. Perforate & test Strawn @ 10342' - 10546'. Acidize w/5000 gals 15% NeFe. Noncommercial.

Set isolation plug @ 10293' w/50' cmt. PBTD @ 10243'. Perforate & test Bone Springs @ 8064' - 8074'.

This zone productive. Will send new 3160-4, C-102 & C-104.
